Staff members present were Justin Jaworski, Executive Director and Roxanne Yielding, Executive Assistant. Darwin Archer attended as a guest. Sean King provided the invocation.
- 2. Green opened the meeting for visitor comments at 4:30pm; no visitor comments were made; Green closed visitor comments at 4:30pm.
- 3. The Board adjourned into Executive Session at 4:30pm pursuant to The Texas Open Meetings Act, Government Code Section:
